## IRPA surveys on education and certification

- Surveys among AS in 1991 and 1994
- Large differences found in formality, legal requirement, recognition and training methods
- EC decided for direct involvement through refresher courses at IRPA Congresses
- Recommendation to AS to include training activities in their meetings
