

History legislation

- 1963: Nuclear Act in place
- ► 1970: Nuclear Act implemented
- ► 1972: Advice of the Health Council of the Netherlands
 - ► 5 Levels of Expertise
- 1973: Implementation by Training Providers
- ▶ 1984: Requirements (K) for Education and Training
- 1987: Recognition of Training Providers
- 2002: Possibility of Recognition of QE by Authorities in legislation
- > 2018: Recognition of RPE by Authorities implemented





History Quality Assurance -1

- ▶ Before 2008: State Commissioner reviews exams
- ▶ Up to 2018: State Commissioner chairs Exam Committee RPE
 - No review of RPO Education
- 2011 2014: Discussion about Recognition of Providers / Courses / Training
- > 2015: Research by NRG
 - QA for whom
 - Goal of QA
 - Stakeholders
- ▶ 2018: New legislation
 - Implementation 2013/59/Euratom





Changes in legislation 2018

2018 QA in Legislation about

- **RPE** Registration of RPE (two levels) Learning Outcomes based on KSC
- RPO Learning Outcomes based on KSC Supervision is added in Training Medical, Dentistry, Veterinary Nuclear industry, Accelerators, NDT NORM, Open Radioactive Sources (dispersible) Measurement and Control



Providers RP training Providers recognised by the Competent Authority



History Quality Assurance - 2

- 2010: College of Training Providers decides on Quality Criteria
 - In Legislation (2015)
- 2014 2015: NRG Study towards Content-related Review of Quality Criteria
 - Review through Self-Assessment
 - Peer Review / Commercial Review
 - Request NVS to organize the review



- 2015 2019: Dutch IRPA association (NVS) establishes ad hoc committee
- > 2019: Dutch IRPA association (NVS) decides to establish a Foundation
 - (Reimbursed) Volunteers



Foundation to Review Quality of Education and Training in RP


- Establishment of the Foundation 2020
- Competent Authority financially supports Implementation QA
- Review process
 - Ad hoc Committee prepares Review of Quality Process
 - Web-based System Self-Assessment
 - Procedures
 - Recruitment Volunteers
 - Pilot

- Preparation Committee Quality Supervision KOS Foundation (discontinued)

- ► Committee for Review





Preparation - Starting Principles

- Content-driven Review
- No Inspection
- Mutual Confidence
- Efficient Input of Limited Time at Reasonable Costs
- Independent Foundation / Committee
- Transparent and Uniform Review
- Participation is Voluntary (Reviewer and Provider)
 - Advantages Training Provider to Participate





Preparation - Process of Review

- Self assessment by Training Provider
 - Training provider
 - Each RP Education / Training offered
- Review of Self Assessment by Commission for Review
 - 2 or 3 Members
 - Review PDCA cycle
 - Review Learning Outcomes content-related
 - Prepare for Site-Visit
- ► Site-Visit





Process of Review(2)

- Concept report
 - Majors / Minors / Suggestions
 - Fact checking by Training Provider
- Action Plan to solve Majors and Minors (Provider)
- Definitive version Review Report submitted to Training Provider
 - Included: Acceptance of solving Majors / Minors
- Training Provider hands over the Report to the Competent Authority during the Recognition Process
